INFORMATION FOR THE STUDENT:

1. Must be enrolled as a full-time student in an Ohio college or university.
2. Student must have completed high school and graduated and have completed their first year (or more) of college.
3. Must be majoring in an agricultural-related field (includes horticulture, forestry, ag-business, etc.).
4. Parent(s) or student must be a resident of Lorain County.
5. Parent(s) or student must be a Lorain County Farm Bureau member for at least one year.
6. Payment for the scholarship will be made to the student after the following:
 - payment receipt for spring quarter/second semester fees (2012)
 - 2.5 GPA or higher for the first quarter/semester
 - must be continuing his/her education in an agricultural field
7. A current college transcript must be attached to the application form; a 2.5 minimum grade point is required for consideration.
8. A signed statement of reference from a non-school individual: a minister, 4-H advisor, or other volunteer leader (not a family member) must be attached.
9. A scholarship committee will screen applications and may interview finalists to select the best prospective student for this scholarship. You may be contacted for a personal interview.
10. Please attach a recent photo of yourself.
